## The First Japanese Company to Lead Manage an IPO in Cambodia

SBI Phnom Penh Securities Co., Ltd. ("SBI Phnom Penh Securities"), the securities business subsidiary of SBI Holdings, Inc. in Cambodia, has been appointed by the Ministry of Economy and Finance of Cambodia to lead manage an initial public offering of state-owned Sihanoukville Autonomous Port ("PAS"), that is scheduled after the stock exchange becomes operational.

In Cambodia, preparations to establish its stock exchange this summer are under way, and SBI Phnom Penh Securities acquired a "full license" for its securities business last October, and is now preparing for the development of a comprehensive securities business after the establishment of the stock exchange. As a lead managing underwriter for the IPO, SBI will contribute to the growth of the Cambodian capital market through assisting PAS in its listing, and will also conduct sales of the underwritten stocks in Japan in conjunction with subsidiary SBI SECURITIES Co., Ltd.

Prior to the establishment of the Cambodian Securities Exchange, the Laos Securities Exchange started trading in January 2011, stock prices of the two listed companies (electricity, bank) have been fairly steady since their offerings, and around 20 companies are now preparing for listing. In Cambodia, where economic growth is anticipated, a substantial development of the capital market is expected. The SBI Group will provide capital required for the growth of Cambodian companies, and will also provide investing opportunities in the burgeoning emerging countries for Japanese investors.

The SBI Group has already established the Phnom Penh Commercial Bank Limited in September 2008 with its investment of 40% of the bank's shares, and will now endeavor to contribute to Cambodia's economic development in both the banking and securities sectors. The SBI Group will continue the overseas development of its financial service businesses, primarily in the Asian emerging countries.
