SBI Holdings, FPT Corporation, and Sumitomo Corporation Announce Strategic Partnership to Provide AI Solution Services

SBI Holdings, Inc. (Head Office: Minato-ku, Tokyo; Representative Director, Chairman, President & CEO: Yoshitaka Kitao; hereinafter "SBI Holdings") announces that it has entered into a strategic partnership with FPT Corporation (Head Office: Hanoi, Vietnam; Founder and Chairman of the Board of Directors: Truong Gia Binh) and Sumitomo Corporation (Head Office: Chiyoda-ku, Tokyo; President and CEO: Shingo Ueno) to accelerate the development of AI technology. Under this alliance, we will jointly invest in FPT Smart Cloud Japan Co., Ltd (Head Office: Minato-ku, Tokyo; Representative Director, President: Nguyen Huu Long; hereinafter "FPT Smart Cloud Japan"), which provides AI solution services, including GPU Cloud resources that are essential for AI applications. After this investment, FPT Corporation's wholly owned subsidiary, FPT Japan Holdings Co., Ltd. (Head office: Minato-ku, Tokyo; President: Do Van Khac), will hold 60% of the ownership, and SBI Holdings and Sumitomo Corporation will each hold 20% of the ownership in FPT Smart Cloud Japan.
